

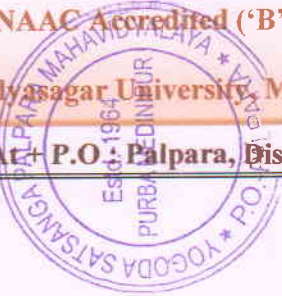

Sub: Prayer for Ramp and Car Charging Points for PWD Students


Respected Sir,
