

The Committee decided to arrange a meeting with PWD Students and their Parents to discuss and know about their specific problems and way out.

The Committee decided to aware the PWD Students about their rights while studing in the College / institution through discussions on the PWD Revised Act, 2016 and supplying a copy of the said Act to every such student.

Subject: Requisition for Sanitary Napkin Vending & Disposal machines in Girls' Hostel.

Sir,

After visiting hostel campus on a regular basis during last one month a very serious fact came to my notice. The fact is about disposal of sanitary napkins.

The present practice: There is a pit within the hostel campus where in the used napkins are being stored over a period of time until the pit becomes full. Those are burnt when the pit is full. Again, dumping of used ones starts after such periodical burning of them. Naturally, the pit also needs to be dig after some time to maintain the holding capacity.


Now, this practice is to be objected by the local people when some used napkins were dropped at their placed by the birds. Additionally, some hostel members have also shown their negative interest about burning out those used napkins out of their personal belief system.

The third important issue which was also noticed is about the stock of fresh napkins. Presently, we do not maintain any stock of sanitary napkin with in the Ladies Hostel and as per my knowledge, neither it is maintained with any ladies washroom of our institution. Now, these three issues together appeared to me a inter-connected, very important to address for the benefit of the reputation of our institution. Looking forward to the solution of the said issue, my suggestion is to provide vending machines along with electric-disposal machines.

These are machines, electrically powered and functions automatically. First come the Sanitary Napkin Vending Machine which can vend one piece of napkin against a piece of 5 Rupees coin dropped into it. Secondly, there will be a separate machine where the used napkins shall be can be dropped and the machine burns it out immediately. The ashes will be stored within the machine, which needs to be cleared periodically. This way, we can facilitate our ladies' hostel, even other ladies wash rooms of our organisaion. As a result, the old objectionable practice will disappear, women of our institution will operate in a far better and hygienic way, and it may be considered as an added facility of the organization from institutional perspective.

I would request you to please allow me to go ahead with the idea.
