About the College

Yogoda Satsanga Palpara Mahavidyalaya, Palpara a Premier Educational Institution under the auspices of Yogoda Satsanga Society of India and Self-Realization Fellowship is situated in the remote south-west corner from the headquarter of the district Purba Medinipur, West Bengal. The Mahavidyalaya was established under the pioneer ship of Sri Janardan Sahu a teacher of outstanding repute and a well-known social reformer of this region under the pioneer ship of the great saint Paramahansa Yogananda of Yogoda Satsanga Society of India has been functioning since 1964. It is a Govt.-Aided Institution recognized by UGC under Section 2(f) and 12(B) of the UGC Act, 1956affiliated to Vidyasagar University, Midnapore at present. Now the College is running with 18 Teaching Departments (Arts-07, Science-09 with Physical Education and B.Ed Department). The Mahavidyalaya is having two Teacher Education Courses recognized by National Council for Teacher Education(NCTE)out of which one is B.Ed. Department functioning as a regular Teaching Department and M.Ed. Department functioning in self-financing mode. It is having Honours teaching facilities in Bengali, English, History, Philosophy, Political Science and Sanskrit in Arts Stream and in Chemistry, Computer Science, Geography, Mathematics, Physics and Zoology in Science Stream.

The Mahavidyalaya is having hostel facilities both for male and female students. A well-equipped Central Library and Seminar Libraries in different Teaching Departments are also available for both teachers and students. The college aims to continue to develop itself into a multi-disciplinary institution focusing on a healthy research culture, value orientation and skill development of students, adapting itself to a technology based, collaborative blended learning approach with the changing times.

The Governance of the Mahavidyalaya lies with the Yogoda Satsanga Society of India through its representatives from the same Society. The position of President and Secretary cum DDO to the Governing Body of the College along with other members as per the Educational Rules of Govt. of West Bengal meant for the composition of Governing Body of Govt. Aided Colleges from time to time.

A Brief History of the College

The history and growth of Yogoda Satsanga Palpara Mahavidyalaya, Palpara as an educational institution is a unique one. Located in Palpara, an illustrious Village in Anchal No. 8/2, P.S. - Patashpur, Dist.- Purba Medinipur, 23 kilometres away from S.E. Railway (Deshapran Station, Bajkul), the Institution holds a distinct status. In1950Palpara M.E.School was raised to the High School standard, and later to Palpara High School affiliated to Yogoda Satsanga Society. Afterwards it became a Higher Secondary and Multipurpose School for boys. In fact, in the year 1964, the present college was first housed in the school building itself. The college was established in Palpara under the tireless efforts of Sri Janardan Sahu of Yogoda Satsanga Society of India, who was the first founder-Secretary of the Institution. Through his generous endeavors, the college became a beacon for disseminating higher education in the rural area of Palpara.

After the independence, prospective students had to go to either Medinipur or Kolkata topursue higher education. Often, more than 80% of the students had to forego their dream of higher studies owing to the high cost of living in such urban areas. To cope up with the difficulties and more over to guard the unsophisticated village students against the sophisticated influence of the metropolis, the selfless and noble hearted Sri Janardan Sahu brought an impassioned appeal for establishing a College to Dayamata, the President of Y.S.S. and Self-Realization Fellowship, Los Angeles, California, U.S.A. The pious and sanity hearted Dayamata with a princely donation of Rs.55,000.00 inspired Sri Sahu, the then Secretary of the local unit of Yogoda Satsanga Branch Centre at Palpara to set up a College. Thus

this Yogoda Satsanga Palpara Mahavidyalaya was founded in 1964 and its affiliation was accorded by the University of Calcutta up to P.U. and B.A. Course for the first time. Sri Sahu, the principal mover to bring the College into existence, became its founder secretary in the beginning. The college was granted extension of affiliation in History Honours in 1967 and also in Philosophy Honours and Political Science Honours in 1968. The authorities of University of Calcutta were pleased to grantthe extension of affiliation in the B.Ed. Course in 1968 and in 1984 the extension of affiliation was granted by the University in B.Sc.Course.

The College was affiliated to Vidyasagar University, Midnapore through a notification issued by the Government of West Bengal with effect from 1st June, 1985. The Vidyasagar University pleased to accord affiliation in Mathematics Honours, Bengali Honours, English Honours, Computer Science and Biology Pass (General) Courses. The College also owes much to the handsome donation made by Sri Arabinda Nath Sasmal, B.A., L.L.B., Monoharchak, Contai, Purba Medinipur, whose ardent zeal for the spread of education and also for philanthropic activities is well known. The kind hearted and enthusiastic Sri Sasmal enriched the College Library with some valuable books for both General and Honours Courses.

Here mention may be made with due respect and gratefulness about some enthusiastic persons like, Late Hemanta Kumar Sahoo (Ex-Secretary of the College), Late Srihari Sahoo (Ex-Secretary of the Y.S.S. Branch Centre, Palpara), Sri Aditya Nath Mishra (Ex-Head Master, Y.S. Palpara Boys' School), Late Dhirendranath Das, Late Radhanath Das Adhikary (Ex-M.L.A., Patashpur) and all other educationists of the locality who rendered their valuable services for all-round development of the College.

The College is situated in a picturesque site amidst the congenial atmosphere, away from the din and bustle of city life. The specious grassy lawn, the shade-giving trees, the big ponds add to the sublime beauty of the Institution. Surpassing its infancy, it is striding towards its youthful vivacity and it celebrated the Auspicious Silver Jubilee in 1989 and Golden Jubilee in 2014. The College was accredited by NAAC with "B" Grade in the 2nd cycle and is being prepared to face NAAC in 3rd cycle. Now the College has long maintained its reputation as a prominent and prestigious educational institution in Purba Medinipur District.

Online Admission Procedure in UG Courses

1. Eligibility

Higher Secondary (+2 Pattern) or any other equivalent examination passed from any Board / Council established by the Government of India or any State Government or any other equivalent examination recognised by Central Board of Secondary Education / Council of Higher Secondary Education / Government of West Bengal / Department of Higher Education (W.B.) / Department of Industry and Technology (W.B.) or any other Department of Govt. of West Bengal or Vidyasagar University. Those joining B.Sc. Course must have passed the above examination under the faculty of Science / Technology / Engineering / Pharmacy etc. There shall be no such restriction for joining B.A. Course.

2. Duration

- i) Duration of the Programme is six or eight (06/08) consecutive semesters of six month seach, i.e., three (03) or Four(04) years and will start ordinarily in the month of July of each year.
- ii) A candidate have to clear all the Semesters within consecutive five (05) years from the academic year of his/her first admission failing which enrolment of the candidate shall stand cancelled.

3. Course of Studies

- i) There shall be two courses of studies leading to B.A./B.Sc. Degree and each course shall be of six or eight (06/08) semesters duration.
- ii) Each B.A. and B.Sc. Degree shall be termed either Honours/ Honours with Research in Single Major or Multidisciplinary Studies Course.
- iii) Six semester will be in three years.
- iv) Each year odd semester (i.e., 1st, 3rd, 5th and 7th semester) will be commenced from July to December and even semesters (2nd, 4th, 6th and 8th semester) from January to June.

4. Admission

- i) The admission to undergraduate Degree Courses will be governed by the guidelines of the Vidyasagar University and that of the Department of Higher Education, Government of West Bengal as framed from time to time.
- ii) A candidate shall be allowed to pursue only one undergraduate degree programme at a time.
- iii) Admission to 1st semester shall be considered upto the period of admission deadline fixed by the Department of Higher Education, Govt. of West Bengal.
- iv) Provisional admission be maintained for next higher semester and admission be automatically confirmed after publication of result except failed/dropout candidates.

5. Registration

- i) Registration is mandatory for prosecuting studies. The registration for UG Degree programme will be governed by Vidyasagar University Regulations relating to Registration.
- ii) A student shall have to submit Registration Form only once at the time entry to the UG Course. He/she shall not be required to renew his/her registration at any subsequent stage.
- iii) A candidate, admitted for a UG Degree Course but not registered, will not be allowed to sit for 1st Semester Examination.

CURRICULUM & CREDIT FRAMEWORK FOR UNDERGRADUATE PROGRAMMES (CCFUP)

Four Year UG Programme as drafted by VIDYASAGAR UNIVERSITY, 2023-24

1. Preamble:

- i. The Govt. of India notified National Education Policy (NEP) on 29 July, 2020 and subsequently UGC developed Curriculum & Credit Framework for UG Programme (CCFUP) based on NEP and it forwarded to all Universities in January, 2023.
- ii. Dept. of Higher Education, Govt. of West Bengal issued directives for implementation of CCFUP on 17 Match, 2023 to all State Universities from the forthcoming session.
- iii. The Vidyasagar University, in concurrence with the academic and administrative restructuring recommended in CCFUP, has designed new Curriculum and Credit Framework for Undergraduate Programme in Semester mode for various disciplines and recommended for its implementation from the Academic Session 2023-24.
- iv. The new Curriculum based on CCFUP has emphasized on continuous learning and evaluation, holistic education by allowing students to experience inter/multidisciplinary and Value Added courses through a 3-Year or 4-Year Undergraduate programme with flexible degree having multiple entry and exit options.
- v. The student is provided abundant opportunities during the programme of study to accumulate credits by opting for Major Courses, Minor Courses, Multidisciplinary Courses, Ability Enhancement Courses, Skill Enhancement Courses and Value Added Courses under various disciplines. Students will choose major, minor, multidisciplinary and other courses at the time of their admission. This system aims to strengthen the academic potential of the student as it provides flexibility in the choice of courses offered beyond the framework of the respective disciplines of study.
- vi. The 4-year undergraduate programme under Vidyasagar University based on CCFUP structures have been designed in the disciplines of Science, Arts, and Commerce as well as professional studies.
- vii.The provisions of these Draft guidelines for Undergraduate Programme of Vidyasagar University under CCFUP (based on NEP, 2020) shall be applicable to students admitted in the Academic Session 2023-24.

2. Proposed UG Programme under Vidyasagar University:

- I. Single Major programme:
- a) 3-year Bachelor's degree programme with Major in Science / Arts / Commerce field of studies (6 semesters with 126 credits)
- b) 4-year Bachelor's degree (Honours) with Major in Science/ Arts/ Commerce field of studies (8 semesters with 166 Credits)
- c) 4-year Bachelor's degree (Honours with Research) with Major in Science/ Arts / Commerce field of studies (8 semesters with 166 Credits) Students to complete research project of 12 Credits in their major area(s) of study in the 4th Year of studies.
- II. Multidisciplinary programme:
- a) 3-year Bachelor's degree with Multidisciplinary programme of studies in Life Sciences / Physical Sciences / Mathematical & Computer Sciences / Social Sciences / Humanities (6 semesters with 126 credits)

3. Type of Awards with stage of Exit (for all programme):

- a) UG Certificate after completing 1 year of study (2 semesters with 40 Credits + Community Service of 4 credits)
- b) UG Diploma after 2 years of study (4 semesters with 86 Credits including Internship/ Apprenticeship/project of 4 credits)
- c) Bachelor's degree after 3-years of study (6 semesters with 126 credits)
- d) Bachelor's degree (Honours) after 4-year (8 semesters with 166 Credits)
- e) Bachelor's degree (Honours with Research) after 4-year (8 semesters with 166 Credits) student to complete research project of 12 Credits in their major area(s) of studies.

The eligibility condition of doing the UG degree (Honours with Research) is-minimum75% marks to be obtained in the first six semesters in aggregates.

Note: As recommended in the CCFUP guidelines, criteria for offering Bachelor's degree (Honours with Research) are to have the facilities - Library, access to journals, computer lab, laboratory infrastructure for research work and at least two permanent faculty members recognized as PhD supervisors. Colleges satisfying the above criteria may offer the Bachelor's degree (Honours with Research) programme.

7. Different Courses:

Major discipline (MJ): Major discipline is the discipline or subject of main focus and the degree will be awarded in that discipline. Courses shall be of 4 credits.

Minor discipline (MI): A minor discipline to be opted from the bunch/ group of subjects assigned for the Major subject. Courses shall be of 4 credits.

Multidisciplinary course (MDC): A multi-disciplinary course is an option to explore disciplines of interest beyond the choices students make in major courses.

Three (03) courses of 3 Credits each are common for all programme:

- i) Multidisciplinary Courses: Three (03) Multidisciplinary courses to be selected from below:
 - Choice for 1st Semester (MDC-1)
 - a) Indian Constitutions

Choice for 2nd Semester (MDC-2)

a) Gender Studies

Choice for 3rd Semester (MDC-3) (any one from below)

- a) Comparative Literature
- b) Basics of Artificial Intelligence (AI)
- ii) Ability Enhancement Courses (AEC): These arc generic courses aimed to enhance skills in communication and local languages. Four (04) SEC courses shall be of 2 credits each distributed in first four semesters.
- Skills Enhancement Courses (SEC): These courses are aimed at imparting practical skills, hands-on training, soft skills, etc., to enhance the employability of students. Three (03) SEC courses shall be of 3 credits each. Colleges shall arrange the skill training to the students in association with Sector Skill Councils (SSC)/ Paschim Banga Society for Skill Development (PBSSD) or any other recognized council/organizations. Separate list of courses under SEC may be provided in due course. Training, assignment evaluation etc. shall be conducted at the College level. SEC courses may also be taken from the SWAYAM/ MOOC/ NSQF platform as per applicability. College authority may designate course coordinator for SEC for each discipline who may guide students to complete the courses.

Value-Added Courses (VAC): Two (02) introductory-level Value added courses are to enhance the standard of the students beyond specified academic curriculum. Courses shall be of 2 credits each.

Two (02) VAC to be selected from below:

For Semester-I: (a) Environmental Studies

For Semester-II: (a) Disaster Management

Summer Internship / Apprenticeship / Community Services: Students will be provided with opportunities for Internship / Apprenticeship / Community Services with nearby locality, local bodies, local industry, business organizations, health and allied areas. It shall be a short - term engagement of 8 weeks in a suitable organization or hands on training in order to gain work experience. There shall be two forms of summer training:

Community Services (4 Credits): In the 1st year of study, students shall be oriented to Community Services during summer term. Minimum 45-60 hours engagement in (a) NCC, (ii) NSS, (iii) Rural Development, (iv) Social Development activities under the supervision of College Teacher.

Internship/ Apprenticeship (4 Credits): In the 2nd year of study, students shall be oriented to Internship/ Apprenticeship. Minimum 8 weeks engagement in local bodies, local industry, NGOs, business organizations, health and allied areas, rural entrepreneurs, local governments (such as panchayats, municipalities), survey, media organizations, artists, crafts persons etc. shall be under the supervision of College. After completion of internship/ Apprenticeship students will have to produce a report related to the work carried out.

Research Project / **Dissertation** (**12 credits**): Students choosing a 4-Year Bachelor's degree (Honours with Research) are required to take up research projects under the guidance of the assigned faculty member of College/ University. The students are expected to complete the Research Project in the 4th Year of study. The research outcome of their project work is to be presented during evaluation and furthermore may be published in journals or presented in conferences etc.

- 8. Modalities of selection of Disciplines/Subjects during Admission:
 - 1. Bachelor's degree of 3-year/4-year programme with Major in Science/ Arts field of studies
 - a) Major- 1 subject
 - b) Minor 2 subjects (according to 6.1/6.2)
 - 2. Bachelor's degree of 3-year/4-year programme with Multidisciplinary Studies in Life Science/ Physical Science / Mathematical & Computer Sc./ Social Sc./ Humanities
 - a) Major- 2 subjects
 - b) Minor -1 subject (according to 6.3)

9. Admission Criteria:

Admission criteria, In-take capacity etc. shall be governed according to the guidelines issued by the Government of West Bengal and Vidyasagar University as applicable time to time. Proposed basic admission criteria applicable only for UG Admission for session 2023-24 with respect to introduction of CCFUP are as follows:

- Candidate passing Higher Secondary Examination (10+2) conducted by the West Bengal Council of Higher Secondary Education or any other equivalent board/council are eligible for admission in the undergraduate programme with Single Major and Multidisciplinary Studies under CCFUP within 3 (Three) consecutive Academic Sessions from the date of passing the qualifying examination.
- 2. Candidate passing Higher Secondary Examination (10+2) from Vocational stream conducted by the respective Board/ Council for vocational studies or any other equivalent board/council are eligible for admission in the undergraduate programme in Multidisciplinary Studies only within 3 (Three) consecutive Academic Sessions from the date of passing the qualifying examination.
- 3. Candidate must have passed in 5 (Five) recognized subjects (excluding Environmental Studies) including at least one language subject in the qualifying examination.
- 4. Students who have passed Higher Secondary or equivalent examination with minimum 45% marks in the Aggregate (to be calculated by adding the marks obtained in 'Best Five' subjects excluding Environmental Studies) along with pass in the subject/related subject or 50% marks in the subject or related subject are eligible to apply for admission in the Single Major (Honours/Honours with Research) programme.
- 5. Students carrying pass marks in Higher Secondary or equivalent examination with at least pass in five subjects (excluding Environmental Studies) are eligible to apply for Multidisciplinary programme under CCFUP. Students from Vocational stream are eligible to apply for Multidisciplinary Studies only fulfilling the other criteria.
- 6. Other UG admission criteria regarding merit point calculation and subject/programme specific requirements shall be as per previous, as applicable.

10. Provisions:

Academic Bank of Credit (ABC): Students must obtain ABC ID during admission process. Provisional (Draft) Guideline: The CCFUP guidelines as mentioned hereunder are provisional (draft) and liable to be changed/modified time to time, as applicable.

B.Ed. & M.Ed. Courses

Admission Procedure for B.Ed. Course

The B.Ed. Department of this Institution was started in 1968 under the University of Calcutta. In 1986, this college was affiliated with the Vidyasagar University. At first, the intake capacity of B.Ed. Department was 150. Since 2007, following the regulations of NCTE, the intake reduced to 100. Previously B.Ed. course was of one year duration. After the implementation of NCET Regulations, 2014, the B.Ed. course became two-year course.

Eligibility:

- Candidates (both fresher & deputed) with at least 50% marks either in Bachelor's Degree and/or in Master's Degree, for SC/ST/PwD (Persons with Disabilities) Category 45% marks either in Bachelor's Degree and/or in Master's degree in Arts/Science/Commerce having two subjects at the Degree level of the available method subjects (Bengali, English, History, Sanskrit, Geography, Mathematics, Life Science, Physical Science and Education) taught in the College are eligible to apply.
- Fresher Candidates must be within 38 years of age as per the circular of the Department of Higher Education, Govt. of West Bengal. Deputed teachers teaching for Classes (V-XII) in W.B. Govt. aided institutions must have at least one year teaching experience as per the circular of the Department of Higher Education, Govt. of West Bengal.
- Reservation of Seats for SC/ST/PwD (Persons with Disabilities) Candidates will be followed as per W.B. Govt. rules.
- If the candidates having subjects either in Hons. Course or in Master's degree other than the school subjects offered in the college may apply for B.Ed. course. They must have any one of the school subjects offered in the college at their graduation level having 300 marks and they will

be treated as B.A./B.Sc. (General) Category. They will not enter their Hons./Master's degree for Qualification details during Online Application.

- B.E./B.Tech. Candidates may also apply, but they must have at least 55% marks (for SC/ST/PwD (Persons with Disabilities Category with 50% marks) with specialization in Science and Mathematics. They will be treated as Science Stream and Hons. Category
- 5% of the total seats will be reserved for Deputed teachers and 95% for fresher's as per the West Bengal Govt. for the Session, 2024-2026
- BCA/B.Sc.(Voc.) degree in UG treated as Pass Category.
- 80% Attendance and above is mandatory as per NCTE Rules. Below 50% attendance students will not be allowed to appear in the B.Ed. Exam under any circumstances.
- Candidates pursuing any other Courses/Job/Full-time Research Work will not be allowed to pursue this Course simultaneously.

Academic Qualification:

Special care should be taken by the Candidates while providing information to this section. They should clearly understand what is a mark obtained and full marks. In case of Vocational Candidates (who are considered as pass graduates) all the examinations Part-I, II & III should be considered and marks obtained & total marks should be rightly calculated. Candidates having Honours in (UG) Degree level, will be awarded grade only for Honours marks. He/ She will be considered as Honours Graduate in the case. Similarly if a Candidate has M.A. & M.Sc. in two different subjects then the qualification acquired later will be considered for determining his/her category & grade calculation. In all the cases each and every candidate should submit the attested Xerox copies of their Mark sheets (both sides) of all the examinations passed.

For Deputed Teachers in Pass scale having Honours Degree and/or PG degree should fill rows corresponding to Pass graduate and Honours graduate both and also the row for PG (if he/ she has PG degree). The Academic grade will be calculated as per scale. However, for eligibility, percentage of marks in Pass/Hons. and PG levels will be checked.

For Deputed Candidates:

For Deputed, all the information should be filled in & verified by the School Authority where the Applicant is serving must be attested & forwarded by Head of the Institution under Office Seal.

NOTE1: It is to note that the duration of the Two-year B.Ed. Course should be mentioned clearly (i.e.2024-2026) in the resolution of Managing Committee of the School.

NOTE1: For all other details and regular updates please visit the online B.Ed. Admission Portal of www. yspm.edu.in.

Reservation of Seats:

For Fresher & Deputed:

Out of the total seats available, 5% seats are allocated for Deputed Teachers & 95% seats are allocated for Fresh Candidates.

Out of total seats in the fresher category, 80% are meant for the students of the Vidyasagar University and 20% for the students other than Vidyasagar University. In case of non-availability of candidates in any category, the seats will be filled up as per rule.-

Reservation of seats for SC/ST/PwD (Persons with Disabilities) candidates will be followed as per West Bengal Govt. rules.

For PwD (Persons with Disabilities) - Minimum Disability of 40% or above will be considered. 3% reservation of seats in PwD (Persons with Disabilities) category will be reserved separately in GEN, SC & ST Category.

Stream-Wise Allocation of Seats:

For Freshers: Stream-wise allocation of seats for freshers will be as follows: Arts-50%, Science-40%, Commerce-10%. In each stream 05% seats will be reserved for Pass Graduates and rest 95% for Honours Graduates & Post Graduates.

For Deputed Candidates: Stream-wise allocation of seats for Deputed Candidates will be as follows: Arts and Commerce Subject Teachers-60%, Science Subject Teachers-40%.

N.B.: There are only Four(04)Pedagogy of School Subjects, these are:

- 1) Pedagogy of Language Teaching for Bengali, English, Sanskrit, Hindi, Urdu & Arabic
- 2) Pedagogy of Social Science Teaching for History, Geography, Political Science, Economics, Education, Commerce, Sociology, Philosophy, Music, Fine Arts & Psychology
- 3) Pedagogy of Science Teaching for Physics, Chemistry, Botany, Zoology, Anthropology, Physiology, Nutrition, Computer Science & Application
- 4) Pedagogy of Mathematics Teaching for Mathematics & Statistics

Pedagogy of School Subjects taught in our Institution:

- 1) Pedagogy of Language Teaching for Bengali, English & Sanskrit,
- 2) Pedagogy of Social Science Teaching for History, Geography & Education
- 3) Pedagogy of Science Teaching for Physics, Chemistry & Life Science
- 4) Pedagogy of Mathematics Teaching for Mathematics only

Selection Procedure:

Calculation of Academic Grade Marks (both Deputed & Freshers)

The Academic grade marks (Deputed/Fresher) will be calculated as per following rules.

- 10% of the percentage of aggregate marks obtained in M.P. or Equivalent Examinations.
- 10% of the percentage of aggregate marks obtained in H.S. or Equivalent Examinations (In H.S. (New) with grading system, the marks obtained in best five subjects including Bengali & English excluding Environmental Studies will be considered.)
- 15% of the percentage of aggregate marks obtained in Degree Pass Examinations
- 20% of the percentage of aggregate marks obtained in Degree Honours Examinations (in such cases the marks of pass examinations will not be considered.)
- 20% of the percentage of aggregate marks obtained in Post Graduate Examinations.

Fresh Candidates:

The selection of fresh candidates will be based on the total academic grade marks calculated as per their academic performance mentioned earlier.

Deputed Candidates:

 Deputed candidates will be selected on the basis of total continuous length of approved Service (Teaching Experience) in Secondary Schools from the entry to the service as per the date prescribed by the Dept. of H.E., Government of West Bengal. The minimum Length of Service is 1 (one) year teaching experience from class (V-XII).

- If the length of service is same for more than one candidate, then academic grade marks will be checked and will be taken into consideration in preparing their merit position. Academic grade marks will be calculated as per the scale of pay of applicant.
- Eligibility % of marks will be checked based on academic qualification of the candidates.

Admission Procedure:

Admission shall be made on merit on the basis of marks obtained in the qualifying examination. Admission process is fully ONLINE basis as per the guidelines of the Vidyasagar University, NCTE and Higher Education Department, Government of West Bengal.

Admission Procedure for M.Ed. Course

The Master of Education (M.Ed.) is a two-year professional programme in the field of Teacher Education which aims at preparing teacher educators and other education professionals including curriculum developers, education policy analysts, planners, administrators, supervisors, school principals and researchers. In 2013, Yogoda Satsanga Palpara Mahavidyalaya got their affiliation from NCTE for M.Ed. course with intake 35. In 2014, Yogoda Satsanga Palpara Mahavidyalaya added a new feature to its crown i.e. M.Ed. course under Vidyasagar University. Previously, the course was of one year duration. Since 2014, the M.Ed. course became two years course and the M.Ed. course was shifted to the West Bengal University of Teachers' Training Education Planning and Administration (WBUTTEPA) as per the order of Higher Education Department, Government of West Bengal. Since then, the intake capacity of M.Ed. course in our institution increased to 50. Now this WBUTTEPA is renamed as Baba Saheb Ambedkar Education University (BSAEU) w.e.f. 27/06/2022.

Duration:

The M.Ed. programme shall be of duration of two academic years including field attachment for a minimum of 4 weeks and research dissertation Students shall be permitted to complete the programme requirements of the two years duration within a maximum period of three years from the date of admission to the programme.

Eligibility:

- (a) Candidates seeking admission to the M.Ed programme should have obtained at last 50% marks or an equivalent grade in the following programme
 - (i) B.Ed.
 - (ii) B.A. B.Ed. / B.Sc. B.Ed.
 - (iii) D.El.Ed. with an undergraduate degree (with 50% marks in each)
- (b) Reservation and relaxation for SC/ST/OBC/PwD and other applicable categories shall be as per the rules of the Central Govt./State Govt.

Admission Procedure:

Admission shall be made on merit on the basis of marks obtained in the qualifying examination. The admission process fully maintained by the Baba Saheb Ambedkar Education University (BSAEU), as per the instructions of the Department of Higher Education of Govt. of West Bengal. The university prepared the merit list and after counseling students list is sent to the College for the admission.

- 1. Online admission process should be done strictly on merit basis.

- 4. Eligible applicants will be notified directly through Portal, SMS and Email at each step.

- Undertaking: Before a student is admitted into the College he/she and his/her guardian shall
 have to sign an undertaking in the proper form to the effect that he/she shall abide by the rules
 of the College.
- Address: Each student must register in the College the address and mobile no. at which he/she
 lives and use. The student must have also informed the office in written at once in case of any
 subsequent change of address.
- Application: Any written application of the students shall be handed over to the Head Clerk or Section Head, who will place them before the Principal. The Principal does not receive application from students directly.
- 4. **Activity:** Students of the College are forbidden
 - i) To belong to any outside athletic club or any other type of club or society.
 - ii) To play or participate for any other team other than College team without previous permission of the Principal in written.
- 5. **Permission:** When a team of students is deputed by the College to go out of the station, the students and staff members accompanying the team must obtain permission from the Principal before their departure from the Institution.
- 6. Certificate: Conduct certificate, University mark sheets and certificates shall be issued on written application through the Academic Section. Duplicate mark sheet and transfer certificate may be issued on deposit of a fixed amount and production of an affidavit and undertaking to the effect that the original mark sheet and transfer certificate was not used for securing admission into any other educational institution.
- 7. Identity Card: Students should always keep their identity cards with them which will entitle them to all privileges of the College. Identity Card must be produced as and when asked for. Anyone who fails to produce Identity Card on demand will be treated as a trespasser. Duplicate Identity Card will be supplied to those who have lost their original Identity Card on payment as fixed by the College.
- 8. **Fees:** Fees and dues are received at the College Counter on the dates fixed for collection. Standing in a queue and paying in the counter form a good manner.
- 9. **Health and Hygiene:** Students shall abide by all hygienic principle and submit themselves to suchanti epidemic procedure as would be laid down by the Principal.
- 10. Club: No club or society can be exis in the College without prior approval of the Principal.
- 11. Vehical Stand: Bicycle/ motor cycle must be padlocked and kept in the place specified for parking. These should not be parked beside gate, main road, beside gardens or other places.

B. Discipline:

- 1. Students should take their seats before the teacher/ lecturer/ professor enters the class room and should not ordinarily leave their seats when the class is going on.
- 2. A student coming late and seeking permission to enter the classroom may be allowed to do sonly at the discretion of the teacher concern.
- In no circumstances the teaching should be interrupted by any student in the class. In case of any
 misconduct in the classroom, disciplinary action will be taken by the Principal on report of the
 teacher concerned.
- 4. Spitting on the walls, floors, pillars, doors, verandas and pavements of the College is strictly prohibited.
- 5. Scribbling, pasting placards or posters or otherwise disfiguring College walls or boards is strictly prohibited.

- 6. Students are forbidden to loiter on the verandas when they have no classes to attend. They should not disturb other classes.
- 7. Students are not allowed to enter the College Office, Principal's Office or staff rooms without permission.
- 8. Students are expected to participate in different extracurricular and co-curricular activities of the College with maintaining decency and decorum. The uncommonly behaviour of any student(such as leaving the hall or room in the middle of a programme or a meeting, unnecessary shouting etc.) shall be considered as an act of gross indiscipline.
- 9. Students may meet the Principal only in urgent need. Before meeting the Principal the students should meet the proctors concerned to discuss their problems.
- 10. Every student should look to the College Notice Board to get necessary information regarding all office orders, decisions and instructions given from time to time. Ignorance of a student due to negligence will not be accepted as an excuse.
- 11. Report regarding undesirable activities on the part of the students will be communicated to the guardians for their information and necessary co-operation in bringing about the improvement of their wards.
- 12. With in the College premises:
 - a) No general meeting of the students of the college or of a section of them may be called without the previous written permission of the Principal.
 - b) No public function to which outsiders are invited shall be organized without the previous permission of the Principal in written.
 - c) No outsider shall be allowed to address the students of the College without the previous written permission of the Principal.
- 13. No theatrical performance, dance or show of any kind shall be allowed within the precincts of the College or outside in the name of the Institution, except with the previous permission in written of the Principal and on such terms and conditions as he may impose.
- 14. No student shall:
 - a) By words spoken or written or by sign or by visible representation offended or insult a fellow student or any teacher of the College, or any employee, officer or authority of the University, or
 - b) Mis-appropriate, destroy, disfigure, or otherwise damage any College or University property in particular furniture, books and apparatus, or
 - c) Disobey any order issued by the University or by the Principal of the College or any rule or order for time being in formed by the university or the College.
- 15. Students have the right to participate in election to various societies held in conformity with democratic principles. In no circumstances should they dabble in any parts or group politics to the detriment of academic interests. Disciplinary action shall be taken against those students who are found guilty or the violation of the rule.
- 16. A student shall be guilty of breach of discipline if he/she breaks any of the foregoing rules or is otherwise guilty of misconduct or indecorous behaviour.
- 17. For a breach of discipline within or outside the precincts of the College, the Principal of the College may
 - a) Impose a fine on concerned student, or
 - b) Suspend the student for one month or less, or
 - c) Expel him/her from the College for such period as he thinks fit.

18. The Principal may, without assigning any reasons require a student to leave the College if he/she consider such action necessary in interest of the Institution. It shall not be opened the student in such cases to ask for the reasons.

C. Class Attendance:

Class attendance means attendance at lecture in honours and general subjects and also tutorial/practical classes of respective subjects.

- a) The students are advised to note the practical or tutorial groups to which they have been assigned. The name of every student is to be entered in the register for general lecture and in the concerned practical/tutorial register concerned. It is the duty of the student to find out whether his/her name has been entered in the appropriate registers. In case the student's name has not been entered, he/she should bring the fact at once to the notice of the officer-in-charge in writing. No complaint at a later stage regarding non-inclusion of any student's name in the concerned registers will be entertained.
- b) Students must be regular in attendance at lectures, tutorials, demonstrations and practical classes. Each year a student is require to attend in each subject a minimum of 75% of total lectures, practical classes and tutorials calculated separately, in order to eligible for attending next university examination.
- c) Absence from the classes and the examinations will be taken seriously except on reasonable grounds. Students are advised not to absent themselves from classes, as otherwise they are liable to be detained for the university examination.
- **D. Time Table:** At the beginning of each semester, students will be provided time table of their detailed classes. Students are require to note the classes assigned to them and attend the classes accordingly.
- **E. Dress Code:** Students are likely to carry decent dress with soothing colours and design. Following are the dresses recommended for boys and girls:

For Boys: Trousers and full sleeve shirt.

For Girls: Salwar-kameez/Churidar/Shari-blouse.

- **F. Anti-Ragging Squad:** As per the order of the Hon'ble Supreme Court of India pronounced on 16.03.2009, "ragging in essence is a human rights abuse. It is a form of systematic and sustained mental and physical abuse of fresh students at the college / University / any other educational institution at the hands of senior students of the same institution and sometimes even by outsiders. It creates a sense of fear in the mind of the first year junior students and they become apprehensive of unforeseen incidents which later come true and culminate in actual form of action."
 - The College has formed an anti-ragging squad to monitor and redress the incidents of ragging in the College Campus. Any student found involved in any form of ragging or any such offence will be expelled from the College and action as deemed fit will be immediately initiated against the culprit.
- G. Anti-Sexual Harassment Cell: As per the guidelines of UGC and the Supreme Court an anti-Sexual Harassment Committee has been established by the College to provide a healthy atmosphere to the students of the College. Anti-Sexual Harassment Committee deals with issues relating to sexual harassment. The Committee is formed to prevent sexual assault, rape and other related crimes on girl students.
 - Anti-Sexual Harassment Cell assures all the complaints of the students, teaching and non-teaching staffs are treated with dignity and respect and the complaints should be maintained confidential.

H. Absent without Notice:

- a) A student remain absent without notice for more than one month, his name will be struck off from the registers.
- b) If he/ she seeks re-admission, he/ she shall be liable to pay all fees (as if his/ her name had not been struck off) including the re-admission fee which is equal to half the monthly Tuition Fee.

I. Withdrawal Certificate:

- a) A student who wants to withdraw from the College must apply in writing for a Withdrawal Certificate in the prescribed form to be had in the College Office during College hours.
- b) Such Certificate may be issued from the College Office with prescribed form on payment of all dues to the College up to the end of the month in which the student applies for withdrawal Certificate.
- c) A student who has been granted Withdrawal Certificate may bere-admitted to the College on payment of all fees as if the certificate has not been granted.
- d) If a student denies to have Withdrawal Certificate for the purpose of sitting at any University Examination as external/ non-collegiate student, he will have to pay a fee equal to one month's Tuition Fee of the class in which here ads last.
- e) If a student becomes absent without notice for more than one month and whose name has been struck off applies a Withdrawal Certificate, he shall have to pay all the College Fees, as if his name had been struck off in addition to such other fees as may be payable.

The College Library

The members of teaching and non-teaching staff and the students of the College are the members of the College Library. The College Library presently contains 37343 books, 25 journals, more than 6000 e-journals and over 2,00,000 e-Books for the benefit of its members.

1. General Rules

- i) Every students hall have to pay a library deposit at the time of admission.
- ii) It is compulsory for every student to have their own library card, which is strictly nontransferable. In case of loss of Library Card, the matter should be immediately notified to the Librarian.
- iii) The library remains open during the college hours in every working day.
- iv) The library books are issued to borrowers between 12.30 p.m. and 3.00 p.m. No issue or return will be made after this period. The last hour of every working day set apart for office work.
- v) Perfect silence to be maintained inside the library premises. All conversations except what is absolutely necessary for the transaction of library business is for bidden inside the library.
- vi) All facilities are given for the free use of books, journals and periodicals in the library itself.

2. General Rules for Borrowers of Books

- i) At the beginning of each session, fresh Library Card will be issued.
- ii) Books may be borrowed for reading in the Library Reading Room using Reading Room Card.

- iii) Librarian will issue weekly notice of home issue of books for students mentioning there group and their respective date of home issue.
- iv) For taking books for home issue, filled up requisition slip should be deposited at the Library counter within 1 p.m. Available books will be issued from 12.30 p.m. to 3.00 p.m. (subject to alteration at the discretion of the Principal).
- v) Student may take out only one book at a time from the Library.
- vi) Students must hand over their Library Card to the Librarian on receipt of the book asked for. The card together with original submitted requisition slip will be kept by the Library Assistant.
- vii) No book shall be taken out of the library without the knowledge of the librarian and until it has been properly entered in the issue register and the entry is attested by the borrower.
- viii) The borrower must examine the condition of the book before he/ she leaves the library. Otherwise, in case of mutilation discovered later, presumption will be made against the borrower and he/ she may be called upon to replace the book or pray the cost with fine.
- ix) Books must be returned by the students within fortnight of the date of issue. However, they may be re-issued for another fortnight if they are un-required by other readers.
- x) No book can be retained for more than 15 days at a stretch.
- xi) If any particular book required for professors/teaching staff, concerned student borrower will be compelled to return it within 24hours.
- xii) Rare manuscripts, Dictionaries and other rare books of reference cannot be taken outside the Library. These books will be marked as "not to be issued".
- xiii) Student borrowing the book for home-use will not be allowed to return it on the same day.
- xiv) If the date of return of book falls on holiday, it should be returned to the library on the next working day.
- xv) All borrowers shall return the books to the library before the College is closed for Summer Vacation and Puja Vacation.
- xvi) Books taken out of the library must be returned to the librarian and not to anybody else. Books must not be passed on to another reader.
- xvii) Books are issued to all Honours students according to the terms and conditions laid down by the Heads of different departments.
- xviii) Issue of story books to the students will be restricted to once a fortnight.
- xix) No day issue will be made to the student on Saturday.
- xx) Members of teaching and non-teaching staff may keep the books they required within along vacation, provided that these books are specially issued for the purpose during the week preceding the commencement of such vacation.
- xxi) No marginal or other notes or marking shall be made in the books nor shall any picture or page be removed or damaged or otherwise disfigured. In such case the borrower may be asked to replace the book damaged by him/her or pay the cost with fine.
- xxii) Any book lost, damaged or defaced by a borrower must be replaced by him/her with fine as it is decided by the authority.
- xxiii) If a borrower keeps a library book for more than the time allowed for the purpose, no more books will be issued to him/ her until the book concerned is returned to the Library.

- xxiv) Students who do not return books within the time allowed will be charged a fine of Rs.2.00 (Rupees two) per book for each day of delay.
- xxv) If a student loses his/her library card, another card will be issued to him/her on payment of Rs.10.00 (Rupees ten) only.
- xxvi) Maximum no. of books to be issued to the borrowers:

a) Teaching Staff including the Principal/Librarian/GLI : 20
b) SACT/CRT : 10
c) Non-teaching staff : 05
d) General Students : 02
e) Honours Students : 04

- xxvii) All books must be returned to the Library at the end of the Collegiate Year. Notice for returning the books will be issued by the Librarian after commencement of examination.
- xxviii) Students must return the Library books along with Library Card before completion of the classes in the Session. They will not be declared sent-up for University examination unless the Library Books lying with the mare returned.
- xxix) Students leaving the College before University examination or discontinuing their studies at anytime shall have to return the books otherwise their T.C. will not be issued.
- xxx) In matter of dispute relating to borrowing/damaging/delaying the return of the books, the Principal's decision is final and binding.
- xxxi) Every student on completion of his/her University examination, shall apply to the Principal for refund of deposit, not later than first week of September next.

3. Seminar Library

Each Honours and General Department maintains a Seminar Library containing both text and reference books along with the periodicals for the use of the students and staff members of the department. The library is maintained at the departmental level for the benefits of the students and staff.

4. LMS Portal

LMS Portal is available in the College Website. It provides a cloud-based, multi-tenant Learning Management System (LMS) that design semester-wise and paper-wise study materials for the benefit of all students. Students may access study materials from LMS Portal.

College Hostel

1. Introduction

There are two hostels of the College, one for boys and another for girls. The boys' hostel provides accommodation for 30 boys from UG Section, B.Ed. and M.Ed. Section. The girls' hostel also provides accommodation for 55 girls of UG, B.Ed. and M.Ed. section. The Principal is the final authority in all matters relating to the hostels. Ordinarily he exercises control and supervision through the Hostel Superintendents and Assistant Superintendents, who are the in-charges of the day today administration of the hostels.

2. GENERAL RULES & REGULATIONS

The students must remember that the Hostel is the home of the students on the Campus and they should display acceptable form of behavior in the Campus as well as outside in such manner so that dignity of the Institution is maintained.

- ii. Pranks, ragging and rowdy games in any form are strictly prohibited.
- iii. Use of electrical appliances like heaters, hotplates etc. in the Hostel Rooms are strictly prohibited.
- iv. Boarders shall be liable to make entry in the incoming/outgoing registers maintained at gate in order to ascertain their whereabouts safety in case of any emergency.
- v. In case of emergency outside office hours, please contact the warden/ any other Hostel Staff available at that point of time.
- vi. Students must not leave the Hostel without permission of the Hostel Superintendent or Warden.
- vii. They must keep their rooms neat, clean and tidy.
- viii. Students shall be allowed to go home twice in a month with written intimation to Hostel Superintendent/ Warden. In case of the same has to be given to the Caretaker/ Warden.
- ix. For cancellation of breakfast, lunch, tiffin and dinner, students must submit prior intimation to the Caterer in 12 hours in advance for breakfast and 4 hours for the rest.
- x. Students must observe discipline in the Hostel and at the Dining Hall. Objection, if any, relating to the quality and standard of food should be brought to the notice of the Hostel Superintendent or Caretaker in writing, through their respective mess committee.
- xi. Students must return to their hostel by 7.30 p.m. The Hostel Gate would be closed at 7.30 p.m. and none would be allowed to enter into the Hostel after 7.30 p.m. without permission of the Hostel Superintendent/ Warden.
- xii. Girls are requested to submit the names of maximum two persons only (except parents) from the guardian who would be allowed to meet them during visiting time from 4 p.m. to 6 p.m. on working days and on Sunday and Holidays from 10 a.m. to 12 noon only. The students must indicate the relationship with such person(s).
- xiii. Students must not involve themselves in any undue incidents/ situation that may by chance arise in or outside the Campus. Severe disciplinary action would be taken against those found to be involved in such incident.
- xiv. They should be friendly with the local residents and neighbors and must not raise high volume or their personal radio, record player etc. and disturb others particularly at night.
- xv. They should carefully maintain the Common Room and preserve the indoor games materials and other articles such as Carom Board, News Paper, Journals and TV set etc. The TV must be closed at 10.30 p.m.
- xvi. The students must not bring any Video Cassettes/Film/CD etc. and see film inside the Hostel either through computer or VCRI, VCD, DVD. This is highly restricted.
- xvii. Possession/ consumption of drugs, drinks of any kind, hard or soft (except cold drink) are strictly prohibited either inside or outside Hostel Campus.
- xviii. Collection of money in the Hostel for any cause, without permission of the College Authority is strictly prohibited.
- xix. Students must not consume additional power for using Heater/ Stove/ Iron in their rooms. They can however use Computer and Table-lamp with the written permission of the Hostel Superintendent / Warden.
- xx. For misuse of electrical facilities (fan, light etc.) in student's absence within the Hostel Room, a spot fine of 100/- per student will be imposed by the respective Hostel Superintendent or the Principal of the Institute from the specific student/ students involved.
- xxi. Relatives/ guest of the students are not allowed to stay inside the Hostel.

Yogoda Satsanga Palpara Mahavidyalaya reserves the right to make addition or alteration to the rules to suit the convenience of the Institution and the students. Students are hereby directed to strictly adhere to these rules. Severe disciplinary action including withdrawal of hostel facility would be taken against those who will violate the rules.

4. Study Hours

Unless otherwise decided by the Superintendent, the following study hour shall be observed on all days during the session except Saturday evening and festival days.

Morning: 7a.m. to 9a.m.

Evening: 7p.m. to 9p.m.

No boarders shall be absent from his/her room or disturb others in any way during the study hours.

5. Bed Time

The time to go to sleep is usually 11p.m. the hostel gate remains closed during the sleeping hours.

6. Hostel Property

Every boarder is responsible for the care of hostel property he uses. Boarders will be charged for all damages caused by them individually or collectively. If the boarded causing the damage is not detected, all the occupants of the room/ rooms in which the damage is done will be held liable.

Boarders are not permitted to use any electrical appliances other than lights and fans. They have to make their own arrangement for electric bulbs and fans.

7. Visitors

Visitors are not allowed to meet the boarders in the rooms during study hours. No outsider is allowed to see a boarder in the hostel at night. In exceptional circumstances, with the prior permission from the Superintendent, natural guardian of a boarder may be permitted to stay for one night provided that his visit has reference to the interest or welfare of the boarder.

8. Discipline

A form of undertaking, duly signed by every boarder that he will abide by the rules of the hostel, will be submitted at the time of taking admission into the hostel. The following shall be considered breach of discipline:

- a) Absence from the hostel without permission.
- b) Continue neglect of study.
- c) Want of cleanliness and tidiness in the room.

- d) Splitting about in the rooms and in the verandah.
- e) Singing and playing on any musical instrument except during specific hours.
- f) Making disturbing noises.
- g) Cycling on the verandah.
- h) Writing on or disfiguring the walls, doors, windows, of the building.
- i) Holding any meeting in the hostel without approval of the Superintendent.
- j) Calling names or any other derogatory behavior towards the hostel and mess employee.
- k) Indulgence in ragging.
- 1) Misconduct of any other form.

The Superintendent will maintain a conduct register in which the names of boarders will be entered in case of misconduct. Gross misconduct or repetition of breach of discipline on the part of a boarder shall render him liable to removal from the hostel.

9. Withdrawal

Withdrawal from the hostel requires sanction of the Principal. Application for withdrawal shall be made to the Principal through the Superintendent who will ascertain that all dues of the hostel have been paid by the boarder. Permission for withdrawal from the hostel will be granted on payment of the hostel leaving fee.
